

Ex-Wife Sues Steve Harvey for "Soul Murdering"



Summary: Steve Harvey has been accused of murdering the soul of his ex-wife.

Steve's ex, Mary Harvey, filed a lawsuit against the mustached TV host, and she is seeking an astounding number--\$60 million! According to Radar Online, who exclusively obtained the suit, the complaint was "bizarre and rambling," and Mary accused Steve of years of "torture" and "soul murdering."

"Soul murdering is a crime not a diagnosis so murder is achieved by a combination of torture deprivation and brainwashing," the lawsuit stated.

Mary also said that Steve had cheated on her and had impregnated the other woman named Terry Smith. According to Mary, Smith had sued Steve after she was pregnant, and the couple had to pay Smith using their joint bank account. Mary said that the pain of the scandal caused her mental anguish.

Steve's attorney, Brandon Williams, denies the claims against the *Think Like a Man* author.

"Mr. Harvey vehemently denies any allegations set forth in the lawsuit," Williams said. "The Complaint is meritless, frivolous and the allegations are completely false. We will vigorously defend/counterclaim against the Complaint."

Steve is currently the host of *The Steve Harvey Show* and *Family Feud*. The in-demand comedian has been frequently in the news for his positive relationship with President Donald Trump, his racist remarks about the sexual desirability of Asian men, and a recent work memo where he detailed rules that stated no one was allowed to speak to him without an appointment. And also, who can forget his infamous Miss Universe mix-up?

Mary and Steve have one child together, and Fox News reported that she was arrested in 2013 for violating a gag order that was a part of their divorce.
